Update on Participating Care Homes

- Welcome to our 10th care home (Clare Hall) who have joined AFRI-c
- 8 of our care homes are doing daily data collection, which is great! Please keep up the good work.
- 1 care home has reported it only takes 30 seconds per resident to complete the daily data collection
- We appreciate that some care homes have been short-staffed due to COVID-19 but it is even more important that daily data collection continues during a COVID-19 outbreak.
- As a reminder, AFRI-c is looking at whether the use of air filters can help prevent winter coughs, colds, flu and COVID-19. The data collected each day will help us answer this



Resident Registry

Please keep your Resident Registry updated with details of any new residents who move into your care home (unless they opt out of study involvement). Please add any new residents in your care home up to 1st May 2022. To add a new resident, open your list of residents (the Resident Registry) in the database:

1. Click "Add New" in the top right hand corner.




2. On the next page, click "Open" in the Resident Screening section and add all necessary details.



If any residents already on the Resident Registry move out of your care home or pass away, please record that on the Daily Data Collection form by selecting the appropriate reason for not completing the form that day.

Staff Absences

Care home managers please ensure all staff absences are recorded in the database as we want to see whether air filters have an effect on staff sickness too. This is recorded anonymously as we are only collecting information on total time taken off and whether this was due to infection. From the main page in the database, click on "Ad-Hoc Forms" in the top right hand corner, select "Staff Absenteeism" and enter the requested information.



AFRI-c Study Amendment

A recent study amendment has allowed us to extend this first Winter period to the end of May 2022 and include residents who are in the care home for at least 1 month of this Winter. This required some updates to the Resident Information Sheets and the Consultee Information Sheets which are all now available as version 4.0 and have been emailed to all care homes. For any resident who has already consented to be in the study, we will send a letter to those residents/consultees explaining the changes.

For any resident/consultee who has been given an Information Sheet but has not yet been consented, the person responsible for discussing consent should:

- Tell the resident/consultee about the change to extend the first Winter period
- Give the resident/consultee version 4.0 of the relevant Information Sheet
- Ensure that the correct version number and date of the Information Sheet are included on the consent form i.e. version 4.0 dated 17 Mar 2022

For any new residents/consultees who have not yet been approached, please ensure that they are given version 4.0 of the relevant Information Sheet. If you have any questions, please do not hesitate to contact us.
